

# Can a power storage rack be placed behind the gate





## Overview

---

The following restrictions are examples that commonly result in permitting and inspection issues if they are not followed. In addition to the Powerwall 3 mounting clearances, all BOS locations must abide by NEC 110. Clothes closets are specifically noted as an area with easily ignitable material (hanging). Does code allow an electrical panel in a storage room?

1) There must be a clear working space in front of the panel that is 30" wide by 36" deep, per NEC 110. Can I install a battery on the exterior of an exterior wall closer than 3 ft to a window and/or a door that enters the attached garage of a dwelling unit?

ESS on the exterior side of exterior walls shall be located not less than 3 feet from doors and windows directly entering the dwelling unit. Also, storage is not allowed in the required working space, per NEC 110.26 (B). So locating a panel behind a major appliance, such as a washer or dryer, is not compliant.

### OSHA Electrical Panels Clearance Requirements , Legal Beagle

To ensure that an electrical panel can be accessed at all times, OSHA determined that the working space in front of the equipment must be at least 30 inches.
