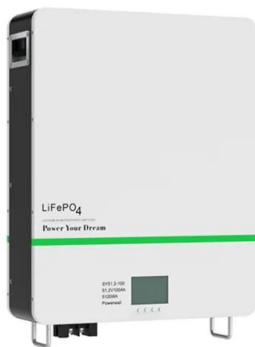
Sinomach signs flywheel energy storage contract
