The 119th Congress (OBBBA) requires that solar and battery energy storage facilities that commence construction after December 31, 2025 comply with certain foreign entity of concern (FEOC) requirements in order to. They're backing it up with MACR requirements that define exactly how much of your system must be "clean. So, it's not just about where the cell comes from, it's about the total financial. In May 2024, the Department of Energy (DOE) issued its final interpretive guidance. The guidance is largely finalized as proposed in December 2023 with refinements and clarification to aid automakers and other stakeholders in identifying FEOCs in their battery supply chains. A major change is coming for commercial solar projects — and it could determine whether your company qualifies for the federal 30% Investment Tax Credit (ITC) for solar or loses it entirely. 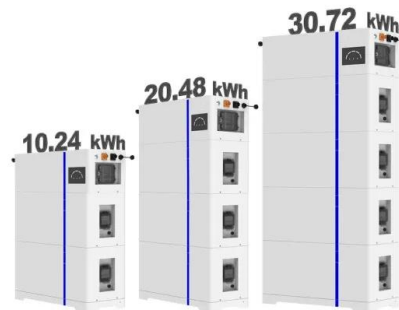
