

# Solar container special bonds





## Overview

---

Community solar is expanding rapidly, growing at an annual rate of 8% to 11%. Even with such strong momentum, these projects can stall without the right credit support in place. Below, we'll outline which bonds typically appear at each stage of a community solar project and. The ideal timing primarily hinges on \*\*a) specific market conditions, b) the prevailing interest rates, c) the maturity profiles of existing debt, and d) the phase of the solar project lifecycle. All surety bonds required in conjunction with the permitting, construction, operation, or decommissioning of a solar generating facility fall into the broad category of solar surety bonds. This process is usually accomplished by installing photovoltaic (PV) panels or through Concentrated Solar Mirrors. 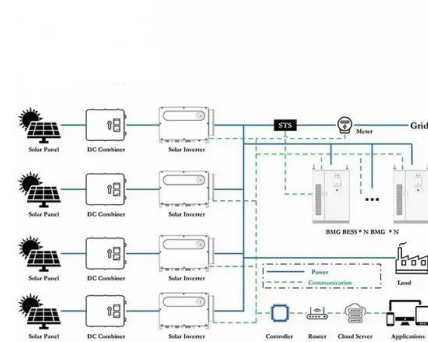
