Overview

The aim of the study is to draw up a recommendation for the optimization of the fire safety of flat roofs with solar panels based on an inventory of several fires and (scientific) investigations into the fire behaviour in comparable constructions. Three Dutch research institutes have released a report detailing fire incidents in buildings with PV systems. Between 2022 and 2023, PV systems were linked to 31 fire accidents across the country. Experts from the Netherlands Institute for Public Safety (NIPV), the Royal Netherlands Standardization.
