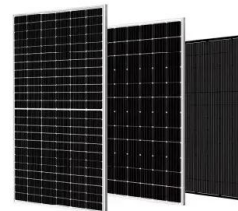

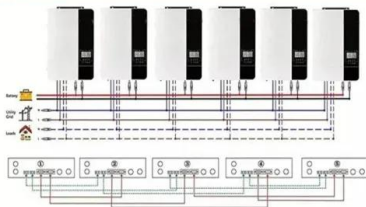

Solar Battery Storage in Australia: Costs, Benefits & Is It Worth It in

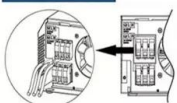
Solar battery storage is worth it in Australia if you use most electricity at night, receive low feed-in tariffs, or want blackout protection. Payback is typically 6-12 years.



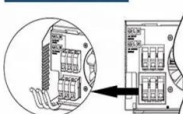
Parallel (Parallel operation up to 6 unit (only with battery connected))

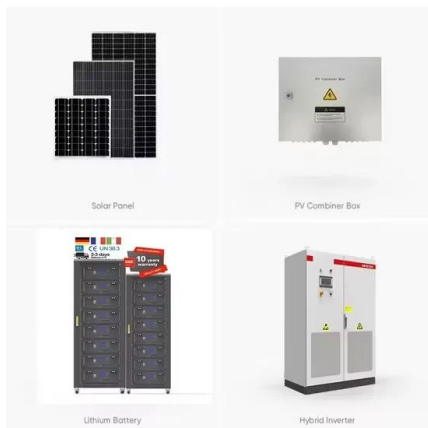
