

The latest implementation standards for solar container vehicles





Overview

Effective voluntarily from January 1, 2025, and mandatory from January 1, 2026, this amendment aligns with the 23rd edition of the UN Recommendations on the Transport of Dangerous Goods, ensuring global consistency in maritime hazardous materials handling. The new EU Battery Regulation represents a significant shift in the way batteries are manufactured, imported, distributed, and managed, particularly for the solar energy storage sector.
